MINUTES OF THE EXECUTIVE SESSION OF JANUARY 12, 2009 AND THE REGULAR SESSION OF JANUARY 12, 2009 were approved on MOTION by Dr. Allan Frost. Affirmative vote was unanimous.

TREASURER'S REPORT: The Treasurer's report was approved on MOTION by Dr. Thad Scholes. Affirmative vote was unanimous.

PRESIDENT'S REPORT:

- 1. The Board approved the fiscal year 2009 Board Meeting Schedule as presented on MOTION by Donna Brizee. Affirmative vote was unanimous.
- 2. Mike Mason reported that Head Start would be receiving additional funding for twenty four children in a new Early Head Start program and funding for thirty four additional regular Head Start children. The College, Head Start and the City of Hansen have also been working on a federal block grant for a new Head Start Center in Hansen.

The Positive Youth Development Project through the Jerome School District was discussed. Mike Mason reported that Head Start finished the year ending December 31, 2008 within budget and were on track to finish the 2009 year within budget.

- 3. The revised budget for fiscal year 2009 for the college was approved on MOTION by Dr. Thad Scholes. Affirmative vote was unanimous.
- 4. The increase in tuition and fees to \$100 per credit for the summer session of 2009 and for fiscal year 2010 was approved on MOTION by Dr. Charles Lehrman. Student Body President Yesica Flores and Student Body Senator Blake Lawson spoke in support of the increase. The increase was also approved by the Student Senate on a unanimous vote.

President Beck thanked the students for their involvement and for taking the time to become informed on the issue.

5. Dr. Jeff Fox and Dr. Edit Szanto presented data concerning student enrollment and student characteristics to the Board. Enrollment grew in all categories discussed. Dr. John Boling, President of the Faculty Senate, stated that he had no complaints from students or faculty concerning the ten percent increase in class size enacted for the spring 2009 semester.

6. Curtis Eaton reported that the College of Southern Idaho Foundation Major Gifts Campaign continued to be well received by donors. He also reported that the internal campaign had gone extremely well. The Foundation plans on giving one million dollars in scholarships to students in fiscal year 2010.

Dr. Beck thanked Mr. Eaton for his work on this project and for all the Foundation does for students.

7. Kathy Clark gave an extensive report on the activities she completed during her sabbatical. Of particular interest to the President and Board was her development of a hybrid Biology 250 course utilizing Adobe Connect.

Chairman Craig and the Board thanked Ms. Clark for her outstanding work. President Beck stated that this was the best evidence of why we have sabbaticals.

- 8. Cesar Perez and Chica Daggett presented the newly formed First Year Advising Booklet. This year long project resulted in an easily understandable step by step process for new students being outlined in an attractive booklet.
- 9. Dr. Edit Szanto presented a revised version of the College of Southern Idaho Strategic Plan. The plan was approved on MOTION by Dr. Allan Frost. Affirmative vote was unanimous.
- 10. President Beck reported the following:
- a. The College received a second Community Based Job Training Grant.
- b. The College is submitting a request to the governor's office for matching funds from the stimulus money for a wind energy/industrial technology/auto body building that will hopefully be funded with funds from the Economic Development Association.
- c. President Beck explained that we spend over two hundred and fifty thousand dollars on contracted interpreters for hearing impaired students each year. He laid the ground work for a legislative request for funding with the House Education Committee.
- d. President Beck asked the Senate Education Committee to look at increasing county tuition.

Re: Proposed Summer of 2009 & Fiscal Year 2010 Tuition and Fee Increases

In light of recent state appropriation holdbacks and the revenue and expenditure projections for next year, it appears we will need to raise tuition. We are recommending the following:

- 1. An increase in summer school tuition and fees from the current \$95 per credit for 12 credits with overload charges starting at over 20 credits to \$100 per credit for all summer school credits taken.
- 2. An increase in the fiscal year 2010 tuition and fees from the current \$95 per credit for 12 credits with overload charges starting at over 20 credits to \$100 per credit with overload charges starting at over 18 credits.

The increase will consist of \$59 for Tuition and \$1 for the Registration Services Fee. Tuition in Fy 2009 was \$594 for a full time student. As per Idaho Code section 33-2110, we are limited in tuition increases to 10% per year.

Full time in state students taking between 12 and 18 credits will see their tuition and fees increase from \$1,140 to \$1,200 which is a 5.26% increase. Part time in state students will see per credit charges increase from \$95 per credit to \$100 per credit. This is the same 5.26% increase.

Foreign and out of state fees for students taking between 12 and 18 credits will increase from \$3,180 to \$3,360 which is a 5.66% increase. Part time foreign and out of state students will see per credit charges increase from \$265 per credit to \$280 per credit. This is a 5.66% increase.

Dual credit fees are set at \$65 in conjunction with a statewide agreement with the Idaho State Board of Education.

This request has been reviewed by and is supported by the administration and the College of Southern Idaho Student Senate. We respectfully request the Board approve the proposed Tuition and Fee increases for fiscal year 2010.
