Re: New Apartment Complex

We have been working on the Dormitory Housing Commission new apartment complex for nearly two years. Starr Corporation was selected as the design builder for the project at the August 16, 2010 regular Board meeting. With the purchase of the 8.54 acres to the south west of campus, the change in zoning for the property and the completion of the design and bidding/negotiating of contracts for construction, we have a proposed construction contract for the project. The project is scheduled for completion in late July of 2013.

The 40 unit two bedroom apartment complex will cost \$6,176,961. Funding for the project is comprised of a \$3,000,000 loan from the Plant Facilities Fund at a 5% interest rate, \$2,000,000 from the bookstore, \$500,000 from the dormitory housing account and the balance, approximately \$676,961, from the student union fund. The annual payment to the Plant Facilities Fund, including principal and interest, would be approximately \$240,000.

The Dormitory Housing Commission met on April 26, 2012 and approved the contract with Starr Corporation for the construction of the apartment complex in the amount of \$6,176,961.

I respectfully request authorization from the Board to enter into a design build contract with Starr Corporation in the amount of \$6,176,961 for the purpose of constructing the Dormitory Housing Commission Apartments.
