New CSI Certifying Official Office Hours

CSI Veterans' Scholarship

The CSI Foundation is sponsoring the CSI Veterans' Scholarship for the sixth year in a row. Three \$1,000 scholarships will be awarded for the 2014-2015 school year. Applicants must meet the following eligibility requirements:

• Must have served in a branch of the United States armed services or the Idaho National Guard and have been honorably discharged on or after January I, 2009.

• Must have a minimum cumulative high school grade point average (GPA) of a 3.0; or have completed at least 12 college credits with a minimum cumulative college GPA of 3.0; or a composite COMPASS score of 195 (reading/writing/algebra) if GED/HSE graduate.

Must be a full-time student (12 or more credits).

For students receiving Chapter 30, 1606, 1607, and VRAP, make sure that you are verifying your attendance at the end of each month. The VA will not issue a payment until attendance verification has been done. This can be done over the phone at 877-823-2378, or online at https://www.gibill.va.gov/wave/.

For those of you who are returning this semester, you may have noticed that I have made some changes to certification. For example, the new CSI VA certification form looks a little different. I have taken out the box to write your courses in. Since the VA will only accept courses that go towards your degree/program, I will only certify the courses that are *required* for your degree/ program. Remember this form *must* be filled out each semester in order to continue utilizing your VA Education Benefits. To ensure payments are processed in a timely fashion, make certain you have met with your advisor and registered in the right courses for your major.

If you find that you are struggling with your course work, there is help available. Stop in to see me during my office hours M-F I-5pm so we can talk about resources available on campus to help you be successful.
